

**AGREEMENT BETWEEN SAN FRANCISCO HOUSING AUTHORITY AND SEIU LOCAL 1021 REGARDING CONTRACT EXTENSION**

The San Francisco Housing Authority (“Authority”) and Service Employees International Union Local 1021 Administrative and Maintenance Generalist (“SEIU”) have reached agreement to extend the April 14, 2017 through September 30, 2019 Memorandum of Understanding’s between the parties as follows:

1. It is hereby understood and agreed that the Memorandum of Understanding’s (MOU) between the SFHA and the Administrative and Maintenance Generalist units for the period of April 14, 2017 through September 30, 2019 shall be extended until September 30, 2021, and;
2. All terms and conditions contained in the MOU’s between the parties that expired on September 30, 2019 shall remain in full force and effect until 11:59 p.m. on September 30, 2021.
3. The Parties agree to begin contract negotiations no later than July 1, 2021.
