

2025 VMRC Chapter Executive Board Election Timeline

Nominations have been extended until February 10th

- Nominations will open on Wednesday, January 8th, and close on January 22nd 5pm
- The Election Committee will be verifying nominees and collecting candidate statements from January 24th – 31st and February 10th -13th.
- Notice of nominees that you will be voting will be posted by February 14th
- NEW Election date: Wednesday, February 19th at 8am closing Sunday, February 23rd at 5pm

ARTICLE III. CHAPTER EXECUTIVE BOARD:

Section 1. The governing body of the Chapter shall be the Chapter Executive Board (hereinafter referred to as the "Chapter Board"). The Chapter Board shall consist of the President, Vice- President/Chief Steward, Secretary-Treasurer, Shop Stewards, up to two (2) Delegates to the State Developmental Disabilities Council.

Section 2. The Chapter Board shall meet at least once every two (2) months. Fifty percent (50%) of all the Chapter Board members shall constitute a quorum. Special meetings may be called by the President upon written request of thirty percent (30%) of the Chapter Board members, or upon the President's own initiative.

Section 3. In the event of an unexcused absence of any Chapter Board member for three (3) consecutive scheduled meetings, such member may be subject to removal from office by two-thirds (2/3) majority vote of the Chapter Board members . The Chapter Board shall notify the chapter membership of the intent to remove such member from office prior to the next scheduled Chapter Board meeting. Chapter Board meetings shall be announced in advance in writing and shall be considered open meetings.

- (a) **Appeals:** Challenges or disputes which are denied or cannot be resolved by the Chapter Election Committee may be appealed in writing to the Local 1021 Executive Board within five (5) working days of receipt of the Chapter Election Committee's decision. The Local 1021 Executive Board shall investigate and respond within fifteen (15) working days of receipt of the challenge. Challenges to the election will be considered valid only if they cite specific violations of the Chapter election rules and procedures, Chapter bylaws, or the Local 1021 Bylaws and Constitution and if the alleged violation may have affected the outcome of the election.

The Election Committee has decided to hold this election electronically. You will be able to vote by SMS text or by email. When voting begins you will receive a text (to your personal cell phone) and an email (to your personal email) with your ballot. You will only be able to vote 1 time either by text or email.

ARTICLE III. CHAPTER EXECUTIVE BOARD:

Section 1. The governing body of the Chapter shall be the Chapter Executive Board (hereinafter referred to as the "Chapter Board"). The Chapter Board shall consist of the President. Vice- President Chief Steward. Secretary- Treasurer. Shop Stewards. up to two (2) Delegates to the State Developmental Disabilities Council.

Section 2. The Chapter Board shall meet at least once every two (2) months. Fifty percent (50%) of all the Chapter Board members shall constitute a quorum. Special meetings may be called by the President upon written request of thirty percent (30%) of the Chapter Board members. or upon the President's own initiative.

Section 3. In the event of an unexcused absence of any Chapter Board member for three (3) consecutive scheduled meetings. such member may be subject to removal from office by two-thirds (2/3) majority vote of the Chapter Board members . The Chapter Board shall notify the chapter membership of the intent to remove such member from office prior to the next scheduled Chapter Board meeting. Chapter Board meetings shall be announced in advance in writing and shall be considered open meetings.

- (a) **Appeals:** Challenges or disputes which are denied or cannot be resolved by the Chapter Election Committee may be appealed in writing to the Local 1021 Executive Board within five (5) working days of receipt of the Chapter Election Committee's decision. The Local 1021 Executive Board shall investigate and respond within fifteen (15) working days of receipt of the challenge. Challenges to the election will be considered valid only if they cite specific violations of the Chapter election rules and procedures, Chapter bylaws, or the Local 1021 Bylaws and Constitution and if the alleged violation may have affected the outcome of the election.
